The International Tribunal for the Law of the Sea is an independent judicial body established by the United Nations Convention on the Law of the Sea to adjudicate disputes arising out of the interpretation and application of the Convention. The Tribunal is open to States Parties to the Convention. It is also open to entities other than States Parties (States and international organizations non-parties to the Convention and natural or juridical persons) in cases provided for in the Convention or other agreements conferring jurisdiction on the Tribunal. *The Yearbook - Annuaire* will give lawyers, scholars, students as well as the general public access to information about the jurisdiction, procedure and organization of the Tribunal and also about its composition and activities in 2008. The *Yearbook* is prepared by the Registry of the Tribunal. Until 2007, it was published in two separate volumes, English (*Yearbook*) and French (*Annuaire*). The *Yearbook - Annuaire 2008* is the first bilingual volume. L *Annuaire* est redige par le Greffe du Tribunal. Jusqu a l annee 2007, il etait publie sous la forme de deux volumes separees, en anglais (*Yearbook*) et en francais (*Annuaire*). Le *Yearbook - Annuaire 2008* est le premier volume bilingue."
